Holt shared information about the COVID-19 flashcard campaign "Each one must reach one." This campaign is using the testimonials of people who have had COVID and write on cards their symptoms, outcomes and encourage people to take the vaccine.  Guillermo Chacon shared the release of the first ever New York City Setting our Agenda, Expanding Latinx Health Action agenda for the next four years. The importance of this agenda is to be proactive and not reactive in terms of issues that are impacting our community. This process has been led by the Latino Commission and the Spanish Health Network and the Spanish Federation with many partners throughout the city, including the People's Republic of Staten Island.  Freddy Molano shared of being involved in vaccination Points of Distribution (POD's) at churches, schools and low-income areas. He is also working with Black Nurses Association for the Greater New York area.  Ngozi Moses shared the maternal mortality and morbidity crisis in Brooklyn faces challenges that COVID has brought. They are organizing, both at the community level and at the hospital level, to bring some improvements and systems that they feel their community needs to strengthen the opportunities that could be there to improve care. They are introducing a model called the Pathways Community Hub and are encouraging colleagues across the city and the state to become interested in the model. |
