To Whom It May Concern:

The enclosed recommend clinical staffing plan includes parts where there was no consensus on the clinical staffing committee. As a result, in accordance with the relevant provisions of the Public Health law, I am utilizing my discretion as President of St. Charles Hospital to adopt those parts of the clinical staffing plan on which there was no consensus. Specifically, the following is an explanation of the elements of the clinical staffing plan where the clinical staffing committee was unable to reach consensus:

While we are disappointed that we were unable to reach consensus in all areas, it is my opinion that the plan as submitted achieves our goal of providing safe and effective patient care and in all instances meets the terms and conditions of the applicable collective bargaining agreement (CBA.) As stated in the CBA: "The required number of staff is determined by the assessment of patients with adjustments based on census, patient flow, acuity level staff skill mix, and competency."

Also included with this letter are the written proposals submitted that the clinical staffing committee was unable to agree upon in the above areas.
