

PUBLIC HEALTH AND HEALTH PLANNING COUNCIL – THE CERTIFICATE OF NEED (CON) PROCESS

The Certificate of Need is the process set forth in Article 28 of the NYS Public Health Law in which the Public Health and Health Planning Council (PHHPC), the Commissioner of Health and the Department of Health (the Department) authorize individuals or business entities to build and/or operate certain healthcare facilities or health care services. The objectives of the CON process are to promote delivery of high quality health care and ensure that services are aligned with community need. The CON provides the Department of Health oversight in limiting investment in duplicate beds, services and medical equipment which, in turn, limits associated health care costs.

The CON process begins when an applicant completes and files a CON application with the Department via NYSE-CON, the Department's electronic CON system. Once a CON application is filed, the public has an opportunity to submit comment to the Department for consideration. Comments should be submitted to the <u>Bureau of Project Management</u>, New York State Department of Health, Room 1842 Corning Tower, Albany, NY 12237.

Once the Department of Health completes the required reviews and makes a recommendation for approval or disapproval, the application is sent to the PHHPC for its consideration. The PHHPC has the authority to approve applications for establishment and make recommendations for approval on construction for consideration by the Commissioner of Health.

Establishment and Project Review Committee Meetings:

Prior to consideration of a CON application by the full PHHPC, the application is reviewed by the Establishment and Project Review Committee (EPRC), a subcommittee of the PHHPC, which generally meets a few weeks before each scheduled PHHPC meeting. This committee is responsible for reviewing CON applications involving construction, service changes or establishment, and transfers of ownership among other things. Possible outcomes of the EPRC meeting include the committee making a recommendation of approval, disapproval or deferral on an application.

During the EPRC meeting where the CON application is considered, members of the public and the applicant are invited to comment.

Information on Public Comment for the EPRC and PHHPC:

The ERPC and PHHPC Agendas are posted to the Department of Health's website a week prior to the meeting at: https://www.health.ny.gov/facilities/public health and health planning council/.

The public has 72 hours prior to the EPRC meeting to submit written public comments to the EPR Committee or the full PHHPC. No written correspondence will be distributed to the Council members the day of the meeting. All correspondence addressed to Council members must be sent to the Council's Executive Secretary no later than 72 hours prior to the meeting at which the application will be presented.

Upon arrival at the EPRC meeting site, members of the public must place their name on the Speaker Sign-in Sheet under the CON application for which they would like to comment. Members of the public must also fill out a Notice of Appearance Form as required by the Joint Commission on Public Ethics. Please note that CON applicants and members of the public are not permitted to speak at the Full PHHPC Council meeting.
