The meeting of the Public Health and Health Planning Council was held on Thursday, December 6, 2012 at the Empire State Plaza, Concourse Level Meeting Room 6, Albany, New York. Chairman, Dr. William Streck presided.

INTRODUCTION:

Dr. Streck called the meeting to order and welcomed Commissioner Shah along with Council members, meeting participants and observers.

MEETING OVERVIEW:

Dr. Streck gave a brief overview of the Council meeting agenda.

RESOLUTION FO APPRECIATION FOR MR. COOK:

Dr. Streck announced that Mr. Cook was retiring from the Department of Health and thanked him for his service to the Council. Dr. Streck read a Resolution of Appreciation signed by the Chair and Vice Chair of the Council noting Mr. Cook's many accomplishments.

REPORT OF DEPARTMENT OF HEALTH ACTIVITIES:

Dr. Streck introduced Commissioner Shah to give the Department of Health Activities Report.

<u>Update on Super Storm Sandy</u>

Commissioner Shah presented a power point presentation updating the members on matters surrounding Sandy. He advised the members that the Department's priority has been to ensure patient safety and access to needed health services. The focus throughout was to support hospitals, nursing homes, adult homes, home care services, and providers. Dr. Shah went into great detail regarding the Department's involvement in relief efforts and concluded by stating that the Department continues to work with facilities in and around the affected areas to assist with storm recovery and help them transition back to normal operations.

Report on Hospital Acquired Infections

Dr. Shah noted that the Department issued its Fifth Annual Report on Hospital-Acquired Infections. The report tracks rates of central-line associated blood stream infections or CLABSIs in ICUs, along with certain surgical site infections and C-difficile. Since the reporting began in 2007, the rate of CLABSIs at New York ICUs has decreased 41 percent and has fallen every year since 2008. Dr. Shah advised members that they can view the published report on the Department's website.

Adult Cardiac Surgery

Dr. Shah encouraged members to download the adult cardiac surgery report found on the Department's website which has shown that in 2010 the in-hospital thirty-day mortality rate for cardiac bypass surgery was one point five eight percent. This is a decrease from the 2009 rate of one point seven nine percent. New York continues to do well or better than the national averages.

World AIDS Day

Next, Commissioner Shah announced that the Department observed World AIDS Day and hosted a two-day healthy living expo in Albany, raising awareness on H.I.V. and AIDS and reducing fear and stigma about the disease and encouraging young people to be engaged in efforts to reduce H.I.V. and AIDS. Dr. Shah thanked the AIDS Institute for creating such an energetic and engaging event.

Health Exchange

Dr. Shah discussed the Department's progress on the exchange. The Department submitted recently a hundred and ninety million dollar multi-year level two grant, which will fund the exchange activities through January 2014. The Department has already received a hundred and eighty-three million. Dr. Shah also noted that the Department's early October meetings with the federal government on the design review of the exchange led to a submission of a blueprint. That blueprint has been submitted and should be conditionally certified by the end of the year,

Mr. Cook

Dr. Shah personally thanked Mr. Cook for his service to the Department. Mr. Cook was instrumental in the Department being successful in many areas such as the HEAL grant program, CON redesign, and NYSECON.

Dr. Shah concluded his report and asked members if they had questions.

Dr. Streck introduced Ms. Block to give the report of the Office of Health Information Technology Transformation activities

Ms. Block updated that Council on the current status of meaningful use dollars. Ms. Block stated the Department continues to be extremely proud at the very hard work that hospitals, physicians, and others have undertaken to reach a goal to have nine thousand eligible professionals to meaningful use. Ms. Block also spoke on matters relating to emergency preparedness, health care operation and creating better ways to set up patient tracking databases.

Dr. Birkhead gave an update on the Sandy response and the Department's concern regarding respiratory health in areas impacted by the storm. Dr. Birkhead supplied the members with a copy of fact sheet on respiratory concerns and mold cleanup with links on it that the Department is asking providers to hand out. The sheet will also be sent out through our network of contractors through the AIDS Institute, through nutrition contractors, family health contractors.

PUBLIC HEALTH SERVICES

Report on the Activities of the Committee on Public Health

Next, Dr. Streck asked Dr. Boufford to report on the Activities of the Committee on Public Health.

Dr. Boufford presented to the Council members the report on the New York State's Health Improvement Plan Prevention Agenda 2013 – 2017. The Public Health Committee has been working very hard over the last six months with really unprecedented collaboration across the state. Over a hundred and forty organizations involved and multiple community engagements.

Dr. Boufford explained there are five major goals. One, is priority areas for all of the people in New York and that includes especially attention to health disparities among racial, ethnic, socioeconomic, and other minorities especially individuals with disabilities. Second goal is the notion of health in all policies. The third goal of dealing with governmental and nongovernmental infrastructure. We want to achieve these changes in health, but we want to leave the partners stronger on the ground at local level and the partnership stronger at the state level to impact these broader determinants of health. Fourth is an enhancement of the infrastructure issue. This would include the Department of Health, OASAS, OMRDD and OMH. Finally, the fifth goal is that the case still needs to be made why prevention and why public health action is important.

Dr. Birkhead also presented on this topic. Dr. Shah thanked the Dr. Boufford and the Committee for their work and completed report. Dr. Boufford made a motion to adopt the Prevention Agenda 2013-17, The State Health Improvement Plan. The motion was seconded and the report was adopted. HEALTH POLICY

Report on the Activities of the Committee on Health Planning

Under the Category Health Policy, Dr. Streck introduced Dr. Rugge to update the Council on the work of the Committee on Health Planning.

Dr. Rugge introduced the CON Redesign Recommendations for adoption by the Council. Dr. Rugge and Ms. Lipson went through each of the 23 recommendations and received comments from the members.

Dr. Shah stated that the recommendations are a testament to this committee that we have been able to make sure that we get what we need out of the rules but we do not overstep our bounds.
