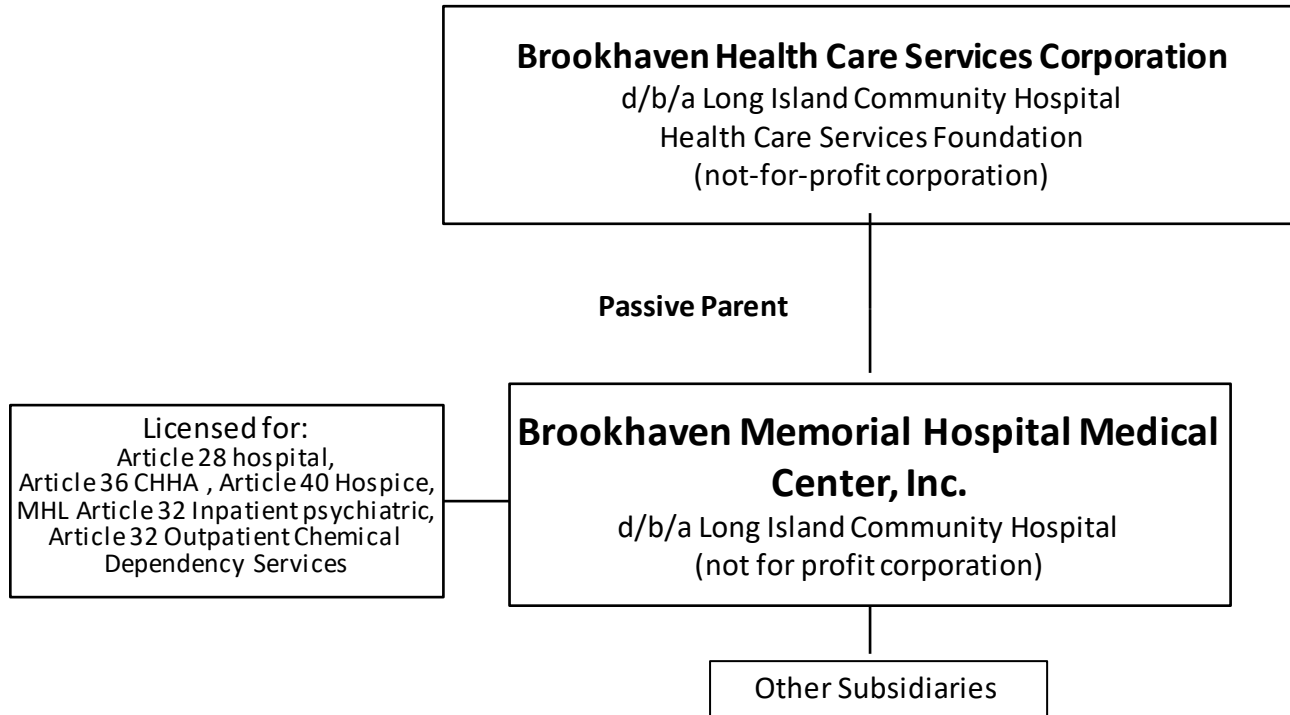

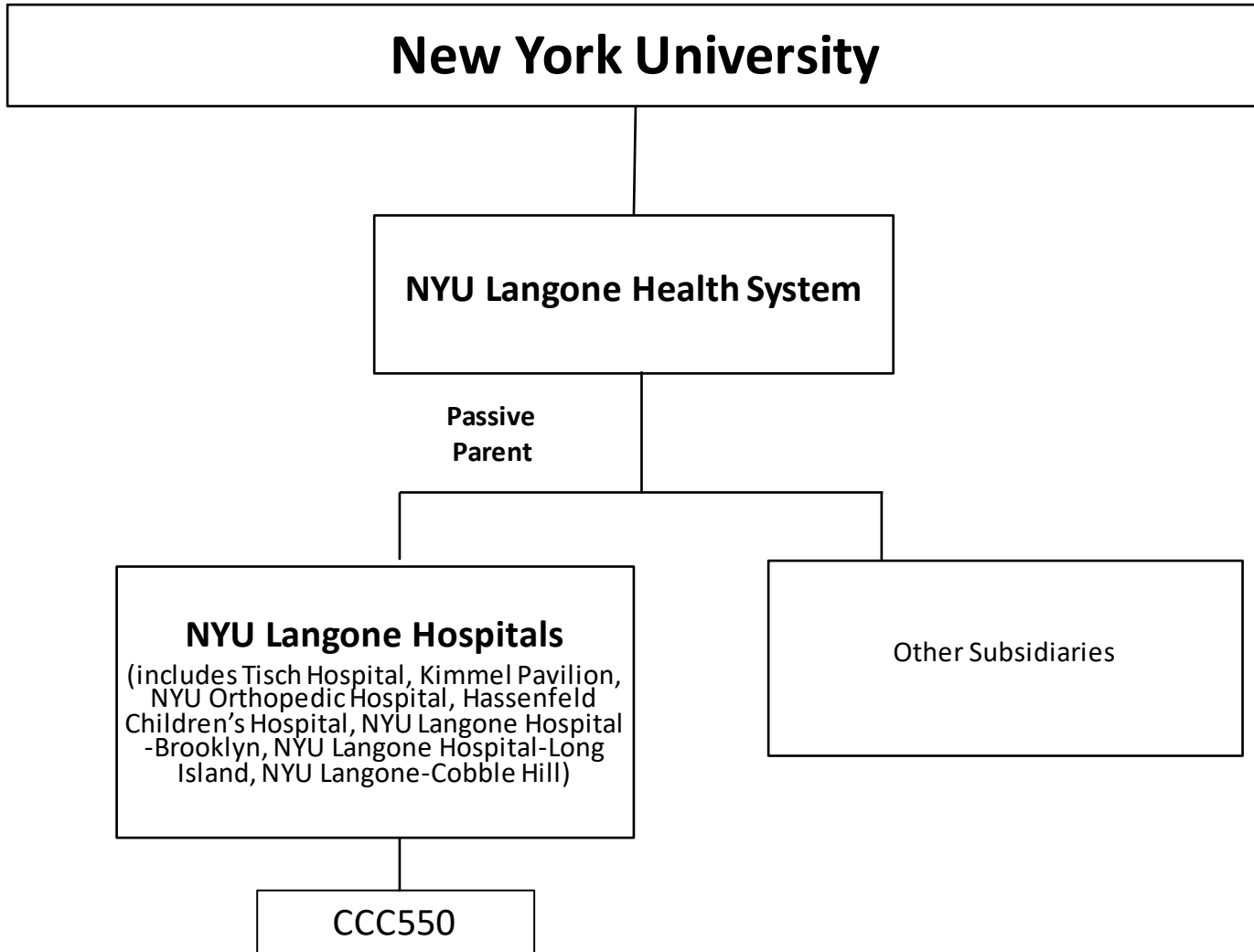

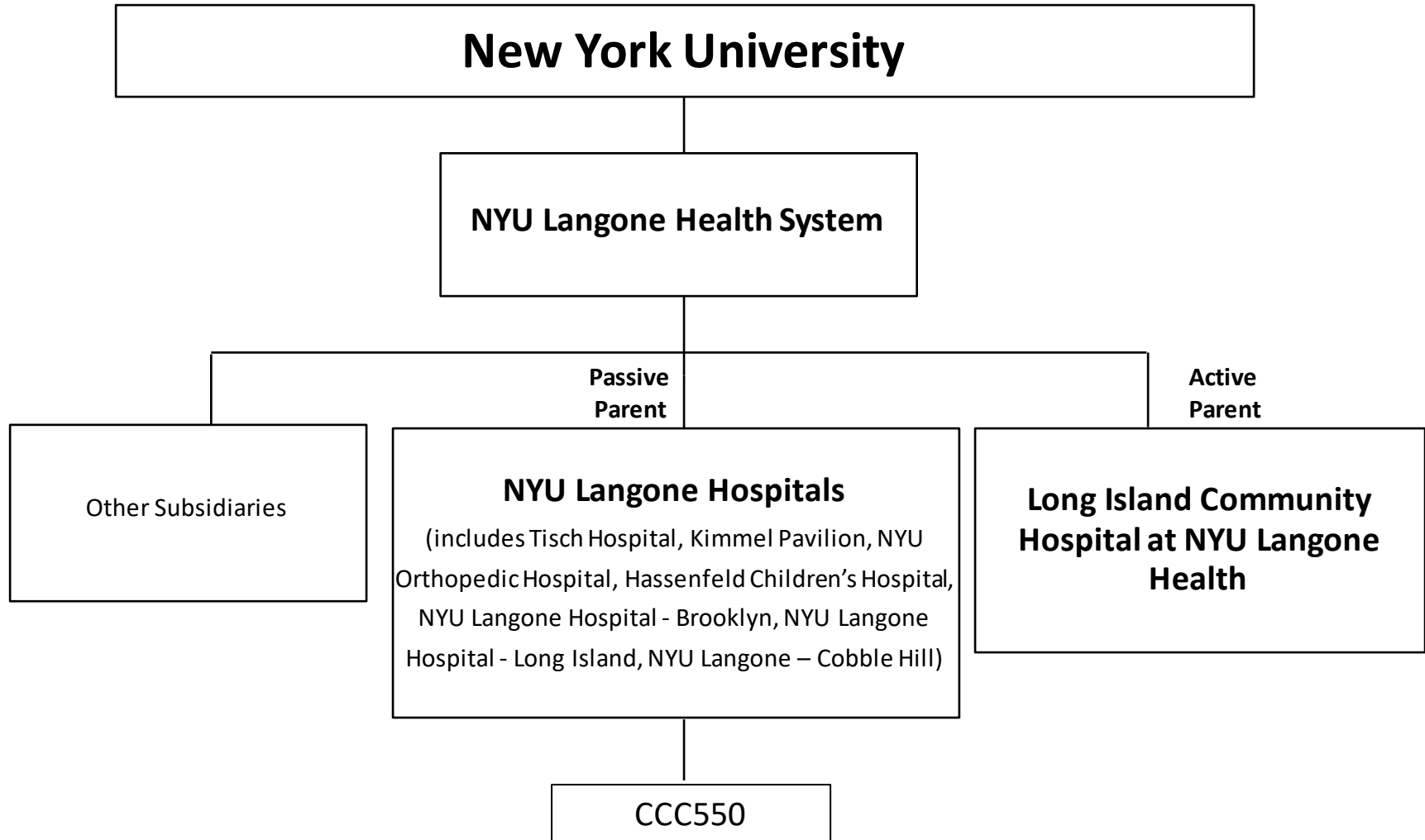


**NYU Langone Health System Organizational Structure

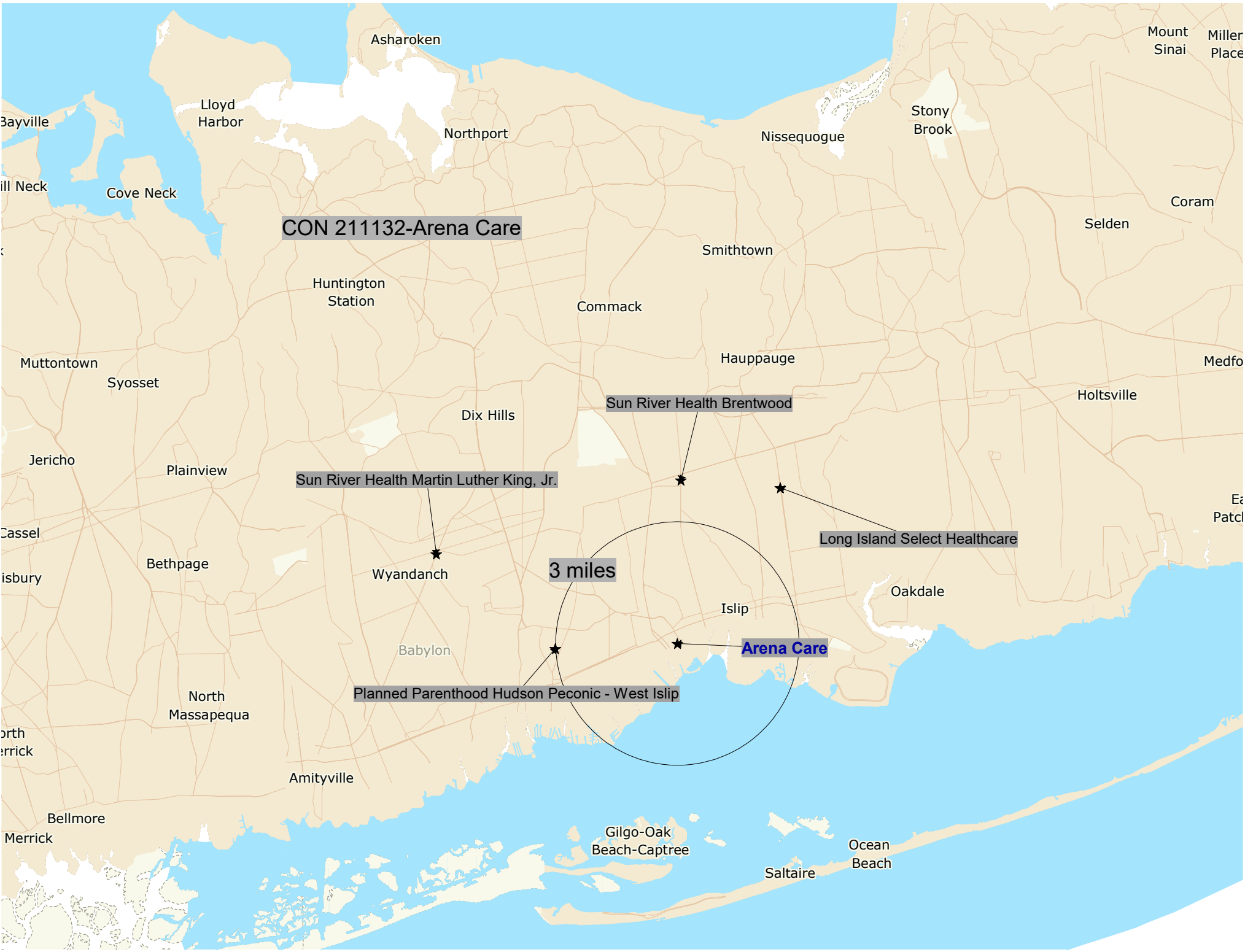

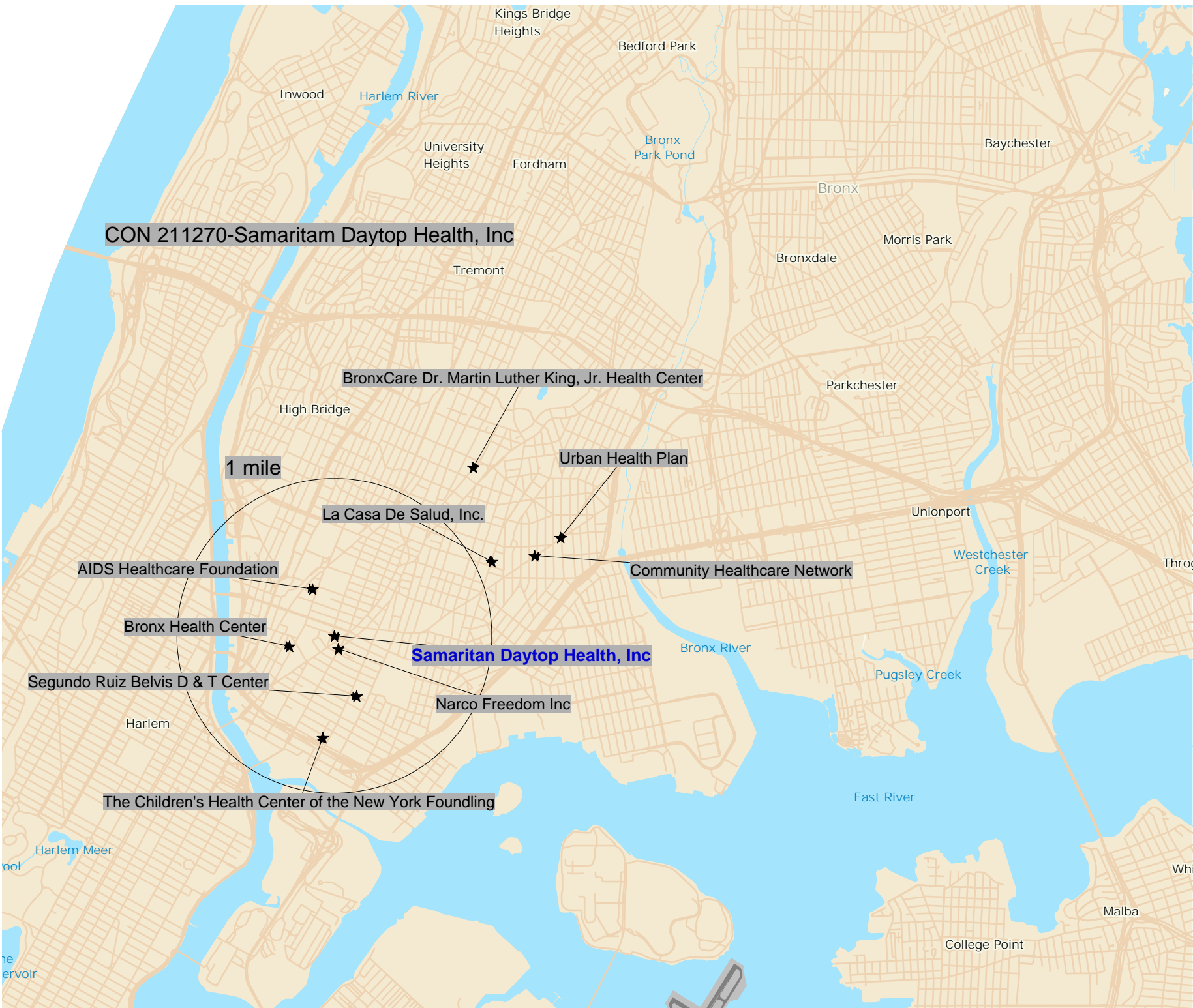

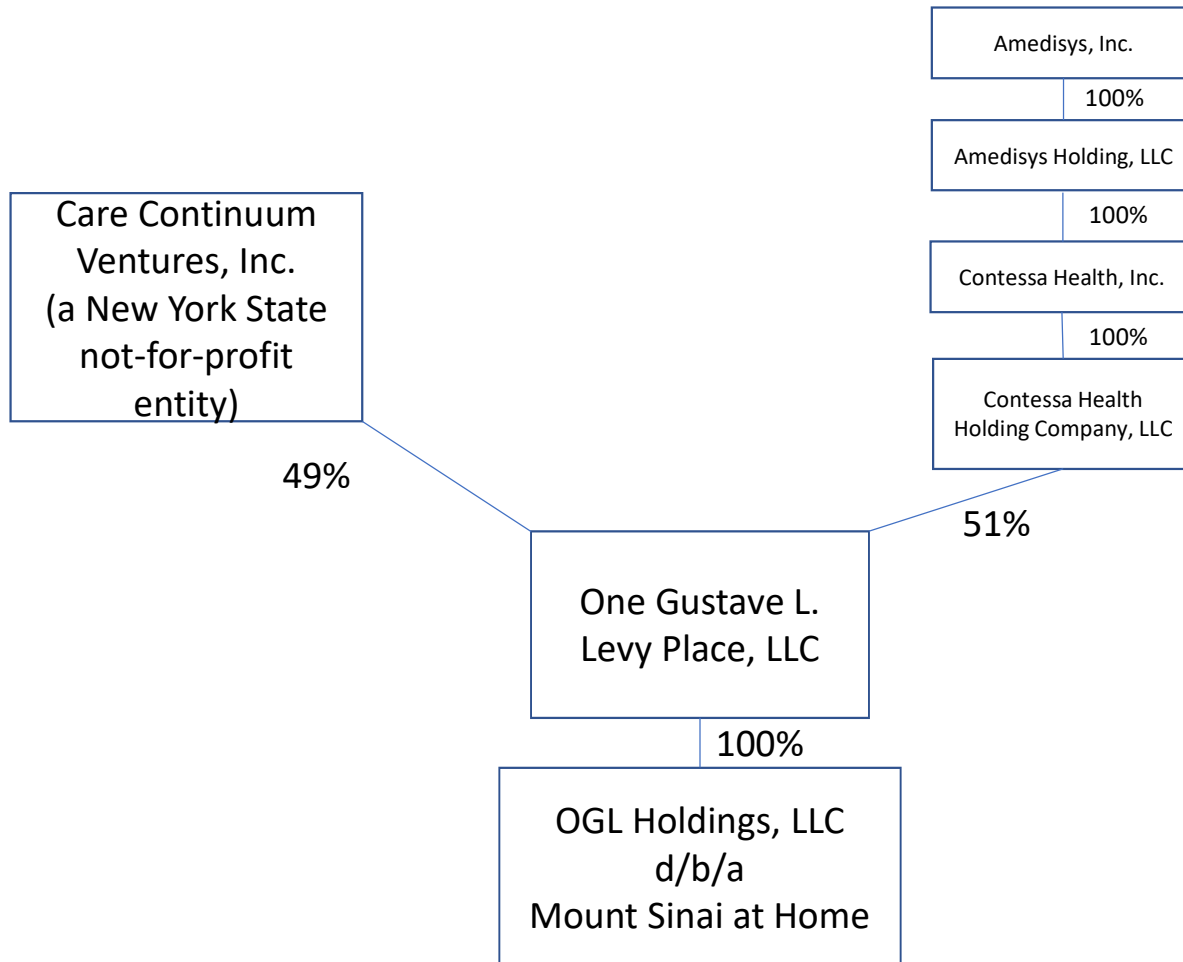
