3.	Process FNS Reports*	First step to creating the USDA-required FNS-44 report. Used to compile payment and application data from CIPS for USDA report on participation and number/type of meals served each month. 4.	FNS44*	Required USDA report. Second step in creating an FNS-44. Creates the actual report from the data compiled. Users have the ability to view and print the report. Needs to be scanned into eFile solution.	State - Accounting	eFile
5.	Late Claim Notice	Used to generate a list of emails or mailing labels for Sponsoring Organizations that have not yet submitted a claim for a particular month. This report also generates the body of the email notification that is sent to the sponsoring organization from a separate email account. 6.	Open Balance Report	Shows all sponsoring organizations with an outstanding debt listed in Accounts Receivable. CACFP Accounting Staff use this report during annual closeout activities.	State-Accounting	Excel pdf

8.	Status Summary Report	High-level report of application and claim statuses. Applications listed by packet item and claims listed by month and their status - the number not submitted, submitted, approved etc. Can identify outliers that enable staff to provide technical assistance to sponsors. 9.	Original Review Report - Homes	A report that includes all identified findings and recommendations from an Administrative Program Review. This report is generated and printed by CACFP Administrative Review Staff and mailed or emailed to Home Sponsoring Organizations. 17.	Billing Request	Part of the accounts receivable process. Creates an invoice (billing request) to be sent to Sponsoring Organizations for debt collection.	State - Accounting	Excel
18.	Accounts Receivable	Lists, by federal fiscal year, all Sponsoring Organizations with an outstanding debt that hasn't been invoiced.	State - Accounting	Excel

22.	Application and Renewal Status	Displays selected agency type (independent, sponsor, homes) and their renewal/update status, for active and inactive.	State	Excel
23.	Center Site Data Query	Displays agency and center information. Must include expiration dates for at-risk eligibility, site type, infants are in care, meal approvals, seconds approval, BFF designation, EWPH participation and license expiration date. 24.	Center Vended Meals	Displays vended meal information for center sites. Includes the vendor name, all the sites for which a vendor provides meals, vendor contract information and meal approvals, and if seconds are approved. 33.	FFATA Quarterly Report (Federal Funding Accountability and Transparency Act) *	Lists all sponsors that have received at least \$25,000 in meal or cash-in-lieu reimbursement for the current fiscal year.	State - Accounting	Excel

Provider Visit Report	Lists all the providers and includes monitoring visit information, such as scheduled dates, actual visit dates, visit times, visit purpose, meal observation, and who conducted the visit.
