Original Language:

4.7.6. The Contractor must provide for or arrange the following mandatory specialty examinations at their proposed site(s): Internal Medicine, Orthopedic, Neurological, Psychiatric, Psychological, Drug/Alcohol, Pediatric, and Speech-Language. Licensed psychologists can perform psychiatric examinations provided the psychologist is board certified or board eligible. (See Exhibit 6)

Revised Language:

4.7.7. The Contractor will provide for or arrange for the following specialty examinations to be conducted at their proposed site(s), if plausible: Internal Medicine, Orthopedic, Neurological, Psychiatric, Psychological, Drug/Alcohol, Pediatric, and Speech-Language. In the event a specialist cannot be obtained for the examination, the Contractor may propose the use of an alternative licensed physician. Such substitution is subject to the approval of the Department, and any proposed physician must be in good standing in order to conduct the specialty examinations.
