		contract" at 365 days? Under what conditions/terms would a 365 day warranty apply?	The per contract warranty period applies to production deployments and final releases.
			For example: the contractor would be required to correct a defect in System Integration Test results that was discovered within 90 days of formal delivery of those results to the Department but would not be required to make this correction more than 90days after contract end if such defect did not cause an issue with production functionality. However, a production defect would need to be corrected if it were discovered at any point during the contract warranty period.
10.	5.4 Payment (page 23)	Please clarify the relationship between overall Task Order budgets and the associated milestone deliverables in terms of monthly payment processes?
