RE: Clarification #8 for Measurement Year (MY) 2022 Updates

Dear Colleague,

Governor

This letter contains information about edits incorporated into the 2022 Quality Assurance Reporting Requirements (QARR) Technical Specifications for Measurement Year (MY) 2022 reporting. The information contained in this clarification has been incorporated into a revised version of the MY2022 PLD File Specifications. The updated files are posted on our Managed Care <u>Information for Health Plans</u> page. The revised specifications should be used in plans' processing for MY2022 QARR.

The scope of the changes include:

- Increasing the column width for IET and PND-E to allow for member appearances in the numerator and denominator that are greater than 9.
- Removing the request for indirect race and ethnicity estimates as a probability as this is no longer required for QARR reporting. There is now a field to indicate how a member's race and/or ethnicity has been determined (e.g., direct or indirect).

This clarification includes the following changes made to the 2022 QARR Technical Specifications Manual:
