The budgeting instructions for determining a <u>child's eligibility</u> for payment of COBRA health insurance and AIDS health insurance premiums have been revised. A copy of the revised budget worksheets for each program should be obtained through the Department of Social Service's Office Automation (DSSP), through ELIB, in the GIS drawer. Each worksheet should be distributed to all Medical Assistance examiners.

COBRA Background and Changes (See 91 ADM-53)

If the adult COBRA Continuation Beneficiaries (CCBs) in the household are determined not to be eligible, then a separate eligibility determination must be made for the CCBs under age 18. Under SSI budgeting for a child under age 18, the needs and income of the parent(s) and any other child(ren) under the age of 18 are taken into consideration through the process of deeming and allocation. When determining COBRA Continuation Program (CCP) income eligibility for more than one child under the age of 18 in a household, a separate SSI budget must be calculated for each child. In each child's budget, the other child(ren) is to be considered non-SSI related for purposes of allocation. The entry of a non-SSI related child with income/resources requires that a Budget Type "05" be utilized. Previous instructions indicated that the Budget Type must be "04".

Districts should note that in determining CCP resource eligibility for more than one child under the age of 18 in a household, the deemed parental resources are equally distributed among the children. When only the CCBs under age 18 in the household are eligible, determine the cost effectiveness of the premium based only on the MA expenditures for an equivalent set of services for the eligible CCBs under age 18.

AIDS Background And Changes (See 93 ADM-28)

If the person with AIDS or the person with HIV-related disease is under the age of 18, meets the AHIP employment eligibility criteria, and resides in a household with an adult or adults determined to be financially ineligible for AHIP, a separate eligibility determination must be made for the person with AIDS or the person with HIV-related disease under the age of 18.
