98 OMM LCM-002 provided districts with instructions for determining continued Medicaid eligibility for children who lost their SSI due to changes in the disability criteria. A list of children who had lost or could be expected to lose their SSI was an attachment to the LCM. Subsequent lists of potentially affected children were sent to districts via BICS, in conjunction with GIS message 98 MA/023 in July and August, 1998.

The Social Security Administration (SSA) has provided states with lists of SSI children who no longer meet the new definition of disability and have exhausted SSA's administrative appeal process or never appealed their original SSI termination. Three such lists will be transmitted to districts via BICS and will be available on Monday, March 22, 1999. The file name for "The SSI Disabled Children Control List" is WMSBSIDC and can be printed using a range of "WM". New York City will receive their reports via the regular file distribution.

These lists have been evaluated for duplicates against other lists that have previously been provided. List #1 will identify 51 children statewide who have not appeared on previous reports. The instructions contained in 98 OMM LCM-002 for continuing Medicaid for these cases should be followed. List #2 of the report will identify 2,442 cases statewide that have appeared on previous reports, but a change has now occurred to either Payment Status and/or Appeal Type and Date. In the event that this report indicates a child's SSI benefits have been terminated, the instructions contained in 98 OMM LCM 002 should be followed. List #3 will identify 21 cases statewide that have appeared on a previous report, but a change has now occurred to one or more of the following fields:

Date of Birth
Federal Living Arrangement
Payee Name, Address, Zip Code
Diary Code and Diary Date

The information contained on List #3 is being provided for informational purposes in the event districts want to insure their cases reflect the most recent material available from SSA.
