Due to a 2.4% cost of living adjustment for SSA payments effective January 1, 2000, several figures used in determining Medicaid eligibility must be updated. Effective January 1, 2000, Medicaid eligibility must be determined using the following updated figures:

- 1. Medicaid income level for 1 is \$600/month or \$7,200/year.
- Medicaid income level for 2 is \$875/month or \$10,500/year.
- 3. Medicaid income level for 3 is \$884/month or \$10,600/year.
- 4. Medicaid income level for 4 is \$892/month or \$10,700/year.
- 5. Medicaid resource levels increase to \$3600, \$5,200, \$5,300 and \$5,350 for households 1, 2, 3 and 4 respectively. The income and resource levels for other size households remain the same as 1999.
- 6. The Federal Benefit Rate (FBR) is \$512/single and \$769/couple.
- 7. The allocation amount is \$275.
- 8. The 249e factors are .954 and .229.
- 9. The SSI resource levels remain \$2,000 for individuals and \$3,000 for couples.
- 10. The state supplement is \$87 for an individual and \$104 for a couple.
- 11. The Medicare Part A premium is \$301.
- 12. The Medicare Part B premium remains \$45.50.
- 13. The monthly QI-2 payment is \$2.87.
- 14. Maximum Community Spouse Resource Allowance is \$84,120.
- 15. Minimum Monthly Maintenance Needs Allowance is \$2,103.
- 16. Maximum Family Member Allowance is \$469/month.
- 17. Please refer to MBL Transmittal 99-5 for 2000 Federal Poverty Levels.

MBL will be programmed to use these figures when a From Date of January 1, 2000 or greater is entered. Upstate mass rebudgeting will occur the weekend of November 27, 1999. These changes will be available on production November 29, 1999.

MBL for NYC will mass rebudget cases the weekend of December 4-5, 1999. These changes will be available on production December 6, 1999.
