The purpose of this Local Commissioners Memorandum (LCM) is to inform local departments of social services (LDSS) of a new Mobius report to identify Medicaid eligible individuals enrolled in Mainstream Managed Care (MMC) who have Comprehensive Commercial Insurance or Medicare.

The new Mobius report, BRMP5520, will assist local districts with identifying individuals that require action to disenroll the individual from MMC. Individuals appearing on this report have been identified as having Comprehensive Commercial Insurance or Medicare. A separate review is not required by the local district. The determination is being made based on the Commercial Insurance policy(s) that an individual has and the associated policy benefit coverage codes (03, 04, 05, 06, 07, 08, 17, 18, 19, 20, 21, 22 and one of the following pharmacy codes:10,11,12). Excluded policies include Worker's Comp (WB) and Auto Accident (AA). If the recipient has Medicare, then Medicare will be listed in the "Coverage" column of the report. Also, if there are multiple commercial policies for a recipient then the report will list the major medical carrier.

The report will be county specific and will list individuals by CIN. The report columns are as follows (see attached sample report):

Client Information (CIN, Last Name, First Name);  
TPL Information (Medicare or OI (other insurance)); and  
Coverage to state "Yes", which will only populate when Comprehensive Commercial Insurance criteria is met.

The new Mobius report BRMP5520 will run concurrently with the BRMP0010 until such time as it is determined that the BRMP0010 can be discontinued. The report will be generated on the 2<sup>nd</sup> day of each month, beginning in February 2020, and will reflect MMC enrollment data as of the first day of the following month. For example, a report generated on the 2<sup>nd</sup> of February, will identify individuals enrolled in MMC as of March 1<sup>st</sup>. The timing of this report will help to ensure that individuals are promptly disenrolled from their MMC plan due to Comprehensive Commercial

Insurance or Medicare. For individuals with Medicare who are receiving long term services and supports, districts are reminded to follow the transition process as outlined in GIS 18 MA/01, "Medicaid Managed Care Transition for Enrollees Gaining Medicare."
