Tier 1 CBO Engagement

Narrative description of current and future plans for contracting with Tier 1 CBOs.

PPS Name:	Central New York Care Collaborative (CNYCC)
<p>CNYCC has worked hard to develop relationships with CBO partners in furtherance of DSRIP goals and objectives. As part of those efforts, CNYCC developed contracting agreements with several Tier 1 CBO organizations. These contracting agreements provide Tier 1 organizations the opportunity to receive funding for participating in DSRIP project activities (as noted a number of organizations have already received funding). CNYCC is also working with the remaining (non-contracted) Tier 1 partners in identifying participation opportunities and establishing contract agreements. In addition to the payments to Tier 1 organizations outlined in the report, upcoming payments are scheduled to be distributed to Tier 1 CBO in upcoming quarters related to participation in project activities and RFP agreements to render services.</p> <p>CNYCC feels that the full-breadth of PPS Tier 1 participation may not be reflected in this report. Due to the truncated timeframe provided to collect this information, CNYCC relied solely on a listing of eligible CBO's as provided in the state Provider Identification Tool (PIT) database. A deeper investigation of the partner network could very well yield additional identification and participation by Tier 1 organizations. CNYCC intends to investigate further to attain a more accurate identification of Tier 1 participation.</p> <p>In addition to direct funding to CBO partners, many of whom are designated as Non-Safety Net organizations, CNYCC has been facilitating relationships between CBO partners and Safety-Net organizations to provide alternative funding opportunities and encourage downstream funding for CBO services.</p> <p>Finally, CNYCC has been conducting monthly meetings with CBO's in the region as part of a dedicated Learning Collaborative. The CBO Learning Collaborative provides an opportunity to discuss DSRIP project implementation activities with local CBO's for project participation and network opportunities with PPS providers. The identification and facilitation of potential relationships between providers and CBO's may yield downstream funding opportunities as DSRIP programming further develops.</p>
