Tier 1 CBO Engagement

Narrative description of current and future plans for contracting with Tier 1 CBOs.

PPS Name: FLPPS

Since its inception, FLPPS has recognized the importance of Community Based Organizations (CBO) and has made a concerted effort to include and fund CBOs delivering services across the FLPPS 13-county region. In the summer of 2016, FLPPS Executive Director, Carol Tegas, established a dedicated team to the work of Community, Consumer and CBO strategy and engagement. As a result, a member of Carol's leadership team, the Director of Strategic Community Initiatives, continued intensive work with strategic community partners and the FLPPS Network CBOs, to establish and draft the FLPPS CBO Engagement Strategy, adopted by the FLPPS Board of Directors and to be submitted to NYS DOH under the Governance workstream's reporting package for DY2 Q3 (January 31, 2017 submission). The purpose of the FLPPS CBO Engagement Strategy is to promote the successful participation of CBOs in Projects and the FLPPS Integrated Delivery System, as well as intensify the level of technical assistance by the centralized FLPPS staff.

Further, as FLPPS progresses in the work of DSRIP project implementation, the inclusion of CBOs in design, implementation and governance demonstrates the efficacy of an integrated system, while also organizing CBOs towards the transition to Value Based Payment (VBP). This body of work includes strengthening existing referral relationships while also building new connections, so that the region's patients can benefit from tight coordination between social/human services, medical services and behavioral health services to provide a true person-centered approach to care. FLPPS has developed a partnership with the Greater Rochester United Way to assist the region's CBOs in thoughtful capacity planning and preparation for VBP, and will explore additional funding streams (State, Federal and Grants) outside the constraints of the 5% cap under DSRIP. The team will use the NYS VBP Roadmap as the primary source to understand the NYS agenda, and prepare both providers and CBOs for formal inclusion in Medicaid VBP arrangements.

To ensure success in this arena, FLPPS is collaborating with its strategic partners to: (1) Continue rapidly connecting social/human service agencies to the FLPPS Integrated Delivery System (service delivery and information technology); (2) Compile standardized data on both program cost and benefit, to establish and demonstrate value of social and human services; and to (3) Determine the impact that CBOs have on population health using collectively prioritized measures. The FLPPS CBO Advisory Council, comprised of United Way, Finger Lakes Health Systems Agency, the Council of Agency Executives, Greater Rochester Health Foundation, Rochester RHIO, Care Coordinated Services Inc, City of Rochester, S2AY Rural Health Network, and several representative CBOs, will advise this strategic partnership. These activities will benefit the larger FLPPS Network, as all contracting organizations (per the June 2016 release of the VBP Roadmap) must include CBOs in VBP payment arrangements Level 2 and above, starting in 2018; the quality/value driven establishment of provider networks that include CBO subcontracting arrangements will be paramount to the success of the newly redesigned Medicaid system. The inclusion of Tier 1 CBOs that provide basic needs to the most vulnerable community members will help stabilize the patients and move them towards living healthier lives, while minimizing avoidable health disparities.

FLPPS will also continue to contract with all CBO Tiers, as FLPPS has done for all contracting cycles, with incentives both tied to Project Milestones and Metrics, as well as subcontracted work related to the organizational workstreams such as Cultural Competency and Health Literacy.
