## New Registry Available for Eligible Hospitals Inside the 5 Boroughs of NYC

Eligible Hospitals (EHs) inside the five boroughs of NYC may now report to the Electronic Case Reporting (ECR) Registry, with the NYC Department of Health and Mental Hygiene (NYC DOHMH). EHs who wish to report to the registry should update their registration of intent and choose "Yes", they intend to submit electronic data to the "Electronic Case Reporting" registry in the Meaningful Use Registration for Public Health (MURPH) System.

Active engagement with the <u>ECR Registry</u> can count as meeting the Specialized Registry Reporting Measure for Meaningful Use Modified Stage 2 of the EHR Incentive Programs.

## **Review or Submit the Public Health Reporting Registration of Intent for 2017**

We highly encourage all providers who have previously registered intent for the Public Health Reporting Objective to review their registration and make any necessary updates. Providers who have not yet submitted a registration should keep in mind that the registration of intent must be completed within 60 days of the start of their chosen EHR Reporting Period.

The registration of intent is completed in the Meaningful Use Registration for Public Health (MURPH) System, which is hosted on the NYSDOH <u>Health Commerce System (HCS)</u>. Please note that only one registration must be submitted and providers should update any existing registration, rather than submitting a new one. Please see the registration guides for additional information on creating a new or modifying an existing registration.
