# **Public Health Reporting LISTSERV: 11/01/2017**

**EHR Incentive Program Public Health Reporting Objective** 



## **30-Day Deadline Reminder**

All providers must register their intent to submit data to public health before or within 60 days of the start of their EHR Reporting Period.

The last 90-day EHR Reporting Period available in 2017 is from October 3, 2017 - December 31, 2017. The final day a registration of intent may be submitted for that period is **Friday, December 1, 2017**. Registration of Intent is submitted via the Meaningful Use Registration for Public Health (MURPH) System, which is hosted on the NYS Health Commerce System (HCS).

<u>Note:</u> Only one registration is required. If you have previously registered, you may "edit" the existing registration with any changes. A new registration should NOT be submitted.

# **2017 Public Health Reporting Objective Requirements**

Providers are required to meet a set number of measures, in order to meet to Public Health Reporting Objective. In 2017, providers may choose to participate under the <u>Modified Stage 2</u> requirements or <u>Optional Stage 3</u> requirements.

#### **Modified Stage 2**

- Eligible Professionals are required to meet 2 Public Health Reporting Measures
- Eligible Hospitals are required to meet 3 Public Health Reporting Measures

#### **Optional Stage 3**

- Eligible Professionals are required to meet 2 Public Health Reporting Measures
- Eligible Hospitals attesting directly with CMS for the Medicare EHR Incentive Program or as dual-eligible are required to meet 3 Public Health Reporting Measures. Eligible Hospitals attesting directly with their state for the Medicaid EHR Incentive Program are required to meet 4 Public Health Reporting Measures.
