## Public Health Reporting LISTSERV: 11/20/2018



### Have You Registered in MURPH?

Eligible Providers must register their intent to submit data to the appropriate Public Health registries before or within 60 days from the start of their EHR Reporting Period. Providers who are using the last 90-days of 2018 as their EHR Reporting Period for PY2018 Meaningful Use, must register by December 1st.

Eligible Professionals who previously registered with MURPH, and need to make any changes, must update their existing MURPH Registration rather than start a new registration.
