PREFACE

The purpose of New York's Adolescent Tobacco Use Prevention Act (ATUPA) is to aid in reducing morbidity and mortality caused by tobacco use by reducing children's access to cigarettes and other tobacco products. It has been well documented that most smokers begin before they are 18 years old and half before they are 15. Many people who start smoking as youth find it nearly impossible to quit during their lifetime. For more than 19 years, state and local enforcement officials have been increasingly successful at reducing youth access to tobacco products and improving retailer compliance with the Adolescent Tobacco Use Prevention Act, realizing a reduction in the rate of non-compliance by retailers from 19.0% in 1997 to 5.79% in 2016-2017.

The Adolescent Tobacco Use Prevention Act requires retailers to obtain positive proof that the person buying cigarettes is over the age of 18. Retailers found in violation of this law are subject to fines and loss of their tobacco registrations and lottery licenses for repeated violations. The law also limits the location of vending machines and limits the venues in which free tobacco products can be distributed. These enforcement measures are aimed at making tobacco products less accessible to minors and are a part of the State's comprehensive anti-smoking program.

This Annual Report is prepared by the Tobacco Enforcement Program, located in the New York State Department of Health's Center for Environmental Health. The report covers the period April 1, 2016 to March 31, 2017. The report includes the following information:

- Number of tobacco compliance checks that were conducted;
- Names and addresses of tobacco vendors who sold tobacco products to youth and were penalized;
- New York State results of 2015 Youth Risk Behavior Survey (YRBS);
- Tobacco sales data from the State Department of Taxation and Finance; and
- Tobacco-related fire injury data from the Department of State's Fire Reporting System.

During the 2016 – 2017 program year, state and local enforcement officers conducted 29,552 inspections of tobacco retailers to assess compliance with the State's Public Health Law (Adolescent Tobacco Use Prevention Act). Of these inspections, more than 22,395 included unannounced compliance checks where minors attempted to purchase tobacco and other restricted products under the direct supervision of the enforcement officials. An additional 7,157 visits were made to determine compliance with Department of Health signage requirements and Department of Taxation and Finance registration requirements, to educate retailers about the Public Health Law, to verify vending machine supervision and location compliance and to investigate complaints. A total of 985 enforcement actions were taken for sales of tobacco products to minors and more than \$922,000 fines were assessed.

In the last 19 program years, State grants totaling nearly \$87.7 million have been awarded to local enforcement officials to implement the Tobacco Enforcement Program, which resulted in a decline in the rate of retailer non-compliance from 19.0 percent to 5.79 percent. From September 1997 to March 2017, more than \$35.8 million in fines have been levied against 46,844 retailers for selling tobacco to minors. The Department of Taxation and Finance has suspended the registrations of 3,198 tobacco retailers as a result of multiple enforcement actions for selling tobacco products to youth. There were also 868 lottery agent licenses suspended for multiple sales to minors. Of the 685,103 compliance inspections that have taken place during the 19 years, 498,128 (72.7%) were conducted with the assistance of minors attempting to purchase tobacco products.

Program Overview

In March 2017, the NYSDOH completed its nineteenth program year of statewide youth tobacco access enforcement. As part of the State's continued commitment to preventing youth access to tobacco, \$5.27 million was awarded to local enforcement officers to determine and enforce retail tobacco vendor compliance with Article 13-F of the Public Health Law, also known as the Adolescent Tobacco Use Prevention Act (ATUPA). This report covers the twelve-month period from April 1, 2016, through March 31, 2017.

The ATUPA enforcement program is part of the State's comprehensive tobacco control initiative, the New York State Tobacco Control Program (NYS TCP), administered by the Bureau of Tobacco Control (BTC) in the Division of Chronic Disease Prevention. In 2016-2017, the NYS TCP was funded through a state appropriation of \$39.3 million and three grants from the federal Centers for Disease Control and Prevention (CDC) totaling \$2.7 million.

The goals of the NYS TCP's comprehensive tobacco control program are to prevent the initiation of tobacco use among youth and young adults, promote adult tobacco use cessation and eliminate exposure to secondhand smoke, with a focus on populations disproportionately affected by tobacco use and related health consequences, i.e., those with low income, low educational attainment, poor mental health and/or substance use disorders. NYS TCP's evidence-based, population-level and policy-driven interventions strive to accelerate tobacco control in New York State. BTC funds and manages statewide and community programs to work towards achieving environmental change on the state and local level and expand tobacco dependence treatment by medical and mental health care systems.

Statewide and local level actions are used to change the community environment to support and reinforce the State's tobacco-free norm and denormalize tobacco use through education and mobilization. BTC funds *Advancing Tobacco-Free Communities* grantees, which consist of two components – community engagement and youth action, branded as Reality Check. Community engagement entails educating local community members, organizations, employers, decision-makers and policymakers about the harms of tobacco use and secondhand smoke exposure to change public opinion about tobacco and tobacco use. Grantees implement a coordinated set of evidence-based strategies to build public and organizational support to foster environments that demand policy change to reduce the impact of retail tobacco product marketing on youth and eliminate secondhand smoke exposure in the places where people live, work, learn and play, including multiunit dwellings and outdoor spaces. Reality Check grantees engage middle- and high school-age youth from diverse economic and cultural backgrounds to change community norms about tobacco use. Reality Check aims to achieve this goal through activities aimed at deglamorizing and denormalizing tobacco use in the youths' communities and by exposing the tobacco industry's manipulative and deceptive marketing practices. Through civic engagement, youth program initiatives include community education linked to social action, media advocacy, community and media events, and advocacy with organizational decision-makers to advance tobacco-free norms through policy change.

Health systems transformation strategies address tobacco dependence treatment and cessation from a health systems and organizational perspective. BTC funds *Health Systems for a Tobacco-Free NY* grantees who work with high-level administrators at large or local medical and mental health care systems to encourage and assist them in adopting and implementing policies to provide evidence-based, guideline-concordant tobacco dependence treatment among disproportionately affected populations as part of routine care.

Mass-reach health communications aim to increase awareness of the dangers of tobacco use and secondhand smoke exposure, motivate tobacco users to quit, provide information about the Medicaid smoking cessation benefit, prevent youth initiation, expose tobacco industry propaganda, deglamorize and denormalize tobacco use, and educate community members and decision-makers about tobacco control. Emotionally evocative paid media campaigns promote tobacco use cessation by motivating tobacco users who want to quit to speak with their health care providers for assistance and providing contact information for the New York State Smokers' Quitline, which offers free telephonic and web-based information, resources, quit coaching and starter kits of nicotine replacement therapy to eligible New Yorkers. Targeted media campaigns also educate health care professionals about their role as providers of tobacco dependence treatment and to increase their knowledge about and use of the Medicaid smoking cessation benefit. Paid media campaigns include television, radio, internet, social media, print and out-of-home advertising.

Grantees, Reality Check youth, and mobilized community members and leaders garner earned (free) media via issued press releases, opinion pieces, letters to the editor and hosted events to draw attention to the problems of tobacco use, youth initiation and secondhand smoke exposure to increase support for policy change that supports the tobacco-free norm.

Surveillance and evaluation activities ensure that the NYS TCP uses effective and proven strategies to obtain the goal of a tobacco-free New York State. These activities monitor program progress and impact, provide technical assistance and guidance, and manage the effective and efficient investment of state and federal tobacco control funding. Evaluation data from media studies, surveys and observational projects contribute to the ongoing improvement of the program, help focus key messaging and determine the effective use of media. The NYS TCP contributes to the science of tobacco control through a variety of data collection activities related to program initiatives and the dissemination of program findings.


Program Purpose

The goal of the Tobacco Enforcement Program is to lower the prevalence of tobacco use among youth by reducing tobacco product sales and preventing the onset of its use by this population. Specifically, the program seeks to improve tobacco retailer compliance with ATUPA.

Status and Accomplishments

The New York State Department of Taxation and Finance (DTF) reports the total number of registered tobacco retailers in New York State, including the total number of vending machines. A total of 21,427 tobacco retailers were registered as of August 2016.

Number of DTF registered tobacco retailers in New York State




DTF reported number of registered vending machines

The total number of vending machines registered in New York State by DTF during 2016 was 91. This is down from 807 registered in 2010 and considerably lower than the 4,434 registered in 2000.

The Family Smoking Prevention and Tobacco Control Act (Tobacco Control Act) (Public Law 111-31; 123 Stat. 1776) was enacted on June 22, 2009, amending the Federal Food, Drug, and Cosmetic Act and providing the U.S. Food & Drug Administration (FDA) with the authority to regulate tobacco products. Effective June 22, 2010 vending machines are only permitted in facilities where no one younger than 18 years of age is present or permitted to enter at any time.


DTF reported number of cigarettes sold in New York State

Approximately 5.33 billion cigarettes were sold in New York State for the fiscal year ending March 31, 2017. Of this number, approximately 1.02 billion were sold in New York City.



DTF reported tax revenue collected in New York State

Excluding local sales tax, the tax revenue collected by DTF from the sale of cigarettes and tobacco products for the fiscal year ending March 31, 2017, totaled approximately \$1.235 billion from retailer licensure, vending machine registrations and the excise tax. Retail licensure and vending machine registrations yielded \$6.706 million in the 2016-2017 State Fiscal Year. The excise tax on cigarettes yielded \$1.152 billion, and taxes on other tobacco products yielded \$76.4 million.



DOH reported the following information:

Number and type of compliance checks conducted in NYS

State and local enforcement officers conducted 29,552 compliance inspections during the program year April 1, 2016 to March 31, 2017. Of these, 22,395 were compliance checks where underage youth attempted to purchase tobacco and other restricted products. Additional visits were made to determine compliance with DTF registration or NYS DOH signage requirements, to educate operators of the Public Health Law requirements, to verify vending machine supervision and location compliance, or to investigate complaints. Appendix 1 reflects a county-by-county listing of compliance investigations. Appendix 1A reflects a county-by-county 5-year summary of the sale to minor violation rate.

Number of complaints filed against registered tobacco retailers in NYS


During the time period April 1, 2016 to March 31, 2017, a total of 386 inspections were conducted in response to 250 complaints received concerning ATUPA violations. Two hundred and five complaints were filed against registered tobacco retailers. Included in Appendix 1 is a county-by-county breakdown of this data.

Retailers reported by local enforcement officers to have paid fines or otherwise penalized due to enforcement action in NYS

During the time period April 1, 2016 to March 31, 2017, State and local enforcement officers conducted 29,552 inspections of tobacco retailers to assess compliance with ATUPA. A total of 985 enforcement actions were taken for ATUPA violations and more than \$922,000 in fines were assessed. The names and addresses of penalized tobacco retailers are listed by county in Appendix 2.

Number of tobacco users and trends among minors in New York State

New York State conducts a Youth Tobacco Survey every other year to develop statewide estimates of tobacco use and related behaviors and attitudes for students from grades 6 to 12. The survey includes questions about tobacco use, exposure to environmental tobacco smoke, minors' ability to purchase or otherwise obtain tobacco products, knowledge and attitudes about tobacco and familiarity with pro-tobacco and anti-tobacco media messages. A total of 65 public, parochial and other private schools agreed to participate in the survey, with a total of 7,259 students completing the survey in 2016. The results of the survey are applicable to New York State youth attending middle school or high school. There has been a significant downward trend in current use of cigarettes by high school and middle school students since 2000. Additional data from the 2016 National Youth Tobacco Survey are found in Appendix 4.



Funding disbursement

Appendix 5 lists the funding amounts distributed to 35 county health departments, the New York City Department of Health and Mental Hygiene, and the New York City Department of Consumer Affairs to conduct youth access tobacco enforcement activities. As guided by Section 1399-hh of the Public Health Law, funding was based on the number of retail facilities registered with DTF to sell tobacco products within the local health department's jurisdiction. Nine NYS DOH district offices conducted compliance checks in the 22 upstate counties that do not, or did not elect to, conduct enforcement activities in their counties.

Enforcement

During the time period April 1, 2016 to March 31, 2017, a total of 251 vendors were reported to DTF for lack of required registration to sell tobacco products. As a result, DTF verified the status of the facilities, directed unregistered retailers to obtain a registration, and fined them up to \$3,500 for non-compliance.

During compliance checks conducted from April 1, 2016 to March 31, 2017, youth purchased tobacco and other restricted products 1,296 times. By the close of the program year, 985 non-compliant retailers were fined \$922,250 for ATUPA violations. Fines collected for this period totaled \$753,701.

During the reporting period from April 1, 2016 to March 31, 2017, a total of 56 retailer registrations to sell tobacco products were suspended by DTF as a result of multiple enforcement actions for selling tobacco to youth. Of this total, 56 were suspended for six months and none were suspended permanently. There were also 25 lottery agent licenses suspended for six months for multiple sales to minor violations.



Fires and related injuries and deaths caused or believed to be caused by tobacco products*

The New York State Department of State's Fire Reporting System data for the period of January 1, 2016 to December 31, 2016 identified 1,050 fires classified as being caused by abandoned or discarded cigarettes. There were 20 deaths and 33 injuries to civilians resulting from fires caused by tobacco products. Eight firefighters were also injured. Appendix 6 includes a breakdown of tobacco-related fire statistics by county.

Survey of attitudes and behaviors regarding tobacco use among minors*

The New York State Education Department conducts a Federal Center for Disease Control and Prevention (CDC) funded statewide "Youth Risk Behavior Survey" (YRBS) of students in New York State schools. The survey contains several questions on youth tobacco use and is conducted every two years. For each survey, a new sample of schools and students is selected; student participation is voluntary. In 2015, 10,834 ninth through twelfth grade students from 54 schools participated. New York State data from the YRBS for years, 2009, 2011, 2013 and 2015 are included in Appendix 3.
