Subject: Biweekly Updated COVID-19  
Vaccine Administration Status

Dear Nursing Home Operators and Administrators:

As the New York State Department of Health (“Department”) continues to recognize COVID-19 as an ongoing threat to the health of long-term care facility residents and staff, this update will detail the vaccination efforts of our nursing homes.

**As of 03/12/2024:**

- The total number of residents in New York State nursing homes is **98,123**.
- The total number of consenting New York State nursing home residents who are awaiting administration of the updated COVID-19 vaccine is **3,875**. This accounts for 3.9% of the total number of residents in New York State nursing homes.
- The total number of updated COVID-19 vaccinations administered to nursing home residents in New York State since **9/15/2023** is **56,198**.
- The total number of updated COVID-19 vaccines administered to nursing home residents in New York State in the **previous seven days** is **1,004**. This accounts for 1.8% of the total number of vaccines administered to nursing home residents since 9/15/2023.
- The total number of New York State nursing homes reporting is **602**.
- The total number of New York State nursing homes that administered the updated COVID-19 vaccine to residents since 9/15/2023 is **573**. This accounts for 95% of the total number of New York State nursing homes.

The Department will continue to extend its efforts to contact nursing homes that have not yet reported vaccinations to understand the potential factors contributing to this concern.

Please note that co-administration of influenza and COVID-19 vaccines is safe and effective and endorsed by the Centers for Disease Control and Prevention (CDC). We expect that all nursing homes take the necessary steps to offer and administer the updated vaccine to all consenting residents and health care personnel, in accordance with Title 10 of New York Codes, Rules, and Regulations, section 66-4.1(a-c).
