

Health Insurance for You and Your Family

MEDICAID

Medicaid is a program for New Yorkers who can't afford to pay for medical care. You may be covered by Medicaid if you have high medical bills, receive Supplemental Security Income (SSI) or meet certain income, resource, age or disability requirements. You can apply for Medicaid by writing, phoning or visiting your local department of social services.

In New York City, contact the Human Resources Administration by calling (718) 557-1399. Residents of the five boroughs of New York City may call toll free at 1-877-472-8411. Pregnant women and children can apply at many clinics, hospitals, and Prenatal Care Assistance Program offices. Call your local department of social services to find out where you can apply.
