New York 2(q)(i)

Effective for freestanding clinic and ambulatory surgery centers, on or after July 1, 2013, the administration of a Long-Acting Reversible Contraceptive (LARC) will be carved out of the APG reimbursement methodology when it is provided on the same Date of Service (DOS) as an abortion. The facility will be reimbursed with state funds only for the abortion procedure through APGs which is a prospective payment system that pays based on a facility's base rate and the service intensity weight of the procedure(s) rendered. The facility will submit a separate claim that will pay \$208 which will cover the cost of the LARC insertion (\$158) and the associated Evaluation and Management services (\$50). The facility will submit a third claim to be reimbursed for the cost of the LARC device at the provider's actual acquisition cost. The cost of the physician's professional services is carved out of the ambulatory surgery center payments; the physician is permitted to submit separate claim for those professional services rendered in an ambulatory surgery center.
