The Behavioral Risk Factor Surveillance System (BRFSS) is an annual statewide telephone survey of adults developed by the Centers for Disease Control and Prevention and administered by the New York State Department of Health. The BRFSS is designed to provide information on behaviors, risk factors, and utilization of preventive services related to the leading causes of chronic and infectious diseases, disability, injury, and death among the noninstitutionalized, civilian population aged 18 years and older.

Breast Cancer Screening

New York State Adult Women, 2016

Introduction and Key Findings

Breast cancer is the most commonly diagnosed cancer and the second leading cause of cancer deaths among women in New York State (NYS). Each year, approximately 15,000 women in NYS are newly diagnosed with breast cancer and approximately 2,600 die from the disease. Risk of breast cancer increases with age and varies across racial groups. White women are more likely than black women to be diagnosed with breast cancer, but are less likely to have breast cancer diagnosed at an advanced stage. Among women with breast cancer, black women are more likely than white women to die from the disease.¹

Screening for breast cancer can increase the likelihood of identifying cancer at an early stage when treatment is most successful. Women aged 50 to 74 years should be screened with a mammogram every two years. Women aged 40 to 49 years, those with a family history or other risk factors for breast cancer, and those who have any symptoms or changes in their breasts should talk to their health care provider about what screening schedule is right for them.² Although breast cancer screening recommendations may vary between organizations, each woman should be aware of her personal risk for breast cancer and decide, with her health care provider, when to start screening.

NYS is close to achieving the Healthy People 2020 objective of 81.1% of women aged 50 to 74 receiving breast cancer screening every two years, with 79.7% of NYS women aged 50 to 74 indicating that they received a mammogram within the past two years.³ However, some subpopulations are less likely to be screened. In NYS, women aged 50 to 74 years without a regular health care provider are significantly less likely to have received a mammogram within the past two years (51.7%) compared to women aged 50 to 74 years with a regular health care provider (81.9%). In addition, women aged 50 to 74 years without health insurance are less likely to have received a mammogram within the past two years (68.1%) compared to women aged 50 to 74 years with health insurance (80.4%), although this difference was not statistically significant (Figure 2). However, of NYS women aged 50 to 74 who have not received a mammogram within the past two years, 91.5% were insured (an estimated 475,000 women) and 83.2% had a regular health care provider (an estimated 463,000 women). These data indicate a need to improve screening in the uninsured population, as well as opportunities for improvement in populations who are engaged in and have access to health care.




Figure 1. History of mammogram (within past year, within past 2 years) among New York State women aged 50 to 74 years, by BRFSS survey year from 2000 to 2016
