Definition of Health

"Health is a state of optimal physical, mental and social well-being."

"Health equity" shall mean achieving the highest level of health for all people and shall entail focused efforts to address avoidable inequalities by equalizing those conditions for health for those that have experienced injustices, socioeconomic disadvantages, and systemic disadvantages.

New York Public Health Law – Article 2F

Intentional....not everyone has the same starting point or the same advantages, yet everyone deserves a fair and just opportunity for the best health outcomes...

"Health disparities" shall mean measurable differences in health status, access to care, and quality of care as determined by race, ethnicity, sexual orientation, gender identity, a preferred language other than English, gender expression, disability status, aging population, immigration status, and socioeconomic status.

New York Public Health Law – Article 2F

"It's about outcomes"

"Social determinants of health" shall mean life-enhancing resources, such as availability of healthful foods, quality housing, economic opportunity, social relationships, transportation, education, and health care, whose distribution across populations effectively determines the length and quality of life.
