SED EIP to 4410 Calculator Updated**

Dear Colleague:

The Bureau of Early Intervention is pleased to report that the NYS Education Department (SED) has updated the EIP to 4410 Calculator located on their website and the calculator is currently available for use. This calculator can be accessed through the following link:

Early Intervention Program Regulations Section 69-4.20, adopted on November 30, 2016, included changes related to transition planning for children transitioning from the Early Intervention Program to services under Section 4410 of the NYS Education Law (Preschool Special Education Program). SED has updated their *EIP to 4410 Calculator* to reflect these regulatory changes.

Changes to the transition calculator:

- The **Notice to Committee on Preschool Special Education (CPSE) of potential eligibility** by field has been updated to reflect the change from 120 days to 90 days prior to the child's potential eligibility, based on 10 NYCRR 69-4.20(b).
- The **Transition Conference Convened by** field has been modified to accommodate the requirement to convene the transition conference at least 90 days prior to the child's eligibility for services under NYS Education Law, or no fewer than 90 days before the child's third birthday, whichever is first, based on 10 NYCRR 69-4.20(b)(4).
- A new field has been added for **Transition Conference Convened no earlier than**. This field reflects the requirement that the conference shall not be held more than nine months prior to the child's third birthday.
- In addition to the regulation changes, updates have also been made to the **Last Date for a child found eligible for CPSE Services to Receive EIP Services** field. This field is now consistent with regulation for children determined eligible for 4410 services who turn 3 years of age on or after September 1st, based on 10 NYCRR 69-4.1(m)(1).

The SED *EI to 4410 Services* calculator is a valuable tool to assist service coordinators with identifying important dates for transition planning.
