Data Dictionary Changes for 2025

- Add field collection for referring hospital prehospital care report (PCR)
- Often unavailable
- Required for NTDS submission
- Next Step – Working with vendor

NTDS 2025 New Fields

2025 NTDS

- Inclusion now includes patients transferred/discharged to hospice – Hospice facility/hospice unit/home Hospice

2025 NTDS Changes: Demographics

- Sex – retired
- Sex Assigned at birth – NEW
- Gender – NEW
- Gender-Affirming Hormone Therapy - NEW

2025 NTDS Changes: Incident

- Incident country, state, county should reflect where the incident occurred
- New edit check: Incident date cannot be later than upload date

NTDS 2025: EMS Universally Unique Identifier (UUID)

- Element cannot be not applicable or not known/not recorded along with any other value

NTDS 2025: Intubation

- NEW
 - Intubation prior to arrival
 - Intubation location
 - Do we need to continue to collect this in NYS Data Dictionary?

NTDS 2025: Edit checks

EDIT check addition: Dates cannot be later than upload date

- Trauma surgeon arrival date
- Emergency Department (ED) hospital arrival date

NEW: ED discharge disposition

- Changed: Operating room (hybrid OR)
- New Interventional Radiation (IR) Suite
- New Hospice – includes hospice facility, hospice unit, home hospice
- If patient was boarded in the ED, the disposition must be the location the patient was ordered to go to after their ED workup was complete

NEW: ED discharge date/time

- If multiple orders were written, report the final disposition order date
- EDIT check: Can not be later than upload date

NEW: Primary Medical Event

- The patient experience a documented primary medical event (e.g., seizure, cerebral vascular accident, myocardial infarction, arrhythmia, syncope, stroke, hypoglycemia) that immediately preceded the traumatic injury

Additional Information: Pre-existing condition

- Collect based on the patient's age on the day of arrival at your hospital
 - Bipolar I/II disorder
 - Ethanol (ETOH) disorder
 - Congenital Anomalies
 - Chronic Obstructive Pulmonary Disease (COPD)
 - Schizoaffective, Schizophrenia
 - Substance use disorder
 - Prematurity
 - Post Traumatic Stress Disorder (PTSD)

NEW: Pre-existing condition

- Bronchopulmonary dysplasia/Chronic Lung Disease
- Autism Spectrum Disorder
- Ventilator Dependence

Abbreviated Injury Score (AIS) Code

AIS codes must be submitted on AIS 2015

Changed: Hospital Events

Acute Kidney Injury (AKI)

- Onset of AKI Stage 3 began after arrival to your ED/Hospital

Pressure Ulcer

- Onset of National Pressure Ulcer Advisory Panel (NPUAP) Stage II began after arrival to your ED/Hospital

Hospital Discharge Disposition

- Changed: Element values adapted from UB-04 Medicare Disposition coding
- Added: Dispo to any Federal Health Care Facility must be reported by selecting the option that most closely aligns to the needs of patients
- If hospital disposition is not applicable – hospital discharge date is reported as not applicable
- Edit check: Date cannot be later than upload date

Trauma Quality Improvement Process Highest Glasgow Coma Scale Total, Glasgow Coma Scale assessment qualifier

Added additional information:

For patient who were discharged from your hospital PRIOR to the next calendar day after Emergency Department /Hospital arrival, the null value “Not Applicable” is reported

Trauma Quality Improvement Program Data Quality Audit Filter

More than 1% of patients with an Injury Severity Score of 75

More than 5% of Adjusted Injury Score codes with a severity of 9

More than 10% of patients with an anomalous (Body Mass Index >100 or <10) or an unknown Body Mass Index

Atypical percentage of records reported with Major Complications (Adults <1% or >15%; Pediatrics > 4%; Level III > 7%)

Average Initial ED/hospital Temperature $\leq 36^{\circ}\text{C}$

More than 10% of patients with an unknown Initial Emergency Department/hospital Temperature

More than 10% of patients with an unknown Length of Stay (LOS)

More than 10% of patients with an unknown Initial Emergency Department/hospital Systolic Blood Pressure (SBP)

More than 10% of patients with an unknown Initial Emergency Department/hospital Pulse

More than 10% of patients with an unknown Initial Emergency Department/hospital Glasgow Coma Scale Motor

More than 10% of patients with an unknown Pre-hospital Cardiac Arrest

More than 10% of patients with unknown Pre-Existing Conditions

More than 1% of patients with unknown Hospital Events
